A meeting of Advisory Committee was held today on 22.04.2024 in the Principal Office regarding the letter no. 642/Teg B/Complaint/2024-25-1327-28, in which NCC Dte PH H Pk Chd (MS Branch) Kendriya Sadan (5th Floor) Sectr - 9 Chandigarh had written that 'being an internal matter of the institute it should be resolved with the involvement of Principal, ANO and Complainant.'

Sh. Love was earlier asked to be present along with his parents. Instead, today he was accompanied by his uncle Sh. Raj Kumar.
